- 1. Basis of Supply or Performance.** Supplier, being the party name on the attached Purchase Order ("Order"), agrees to supply the Products and/or perform the Service listed on the Order on the terms and conditions contained herein, which shall be the exclusive statement of agreement between the parties. These terms may not be varied unless in writing signed by an authorized officer of each party.
- 2. Prices.** Prices specified on the Order shall remain fixed unless expressly varied by Rohm Semiconductor India Pvt Ltd in writing. Supplier shall pass onto Rohm Semiconductor India Pvt Ltd the benefit of any price reductions occurring prior to the date of delivery. The prices shall be deemed to include all things necessary for the supply to the Products and / or performance of the Services, including packaging, freight delivery costs and insurance, and no other charges shall apply unless stated on the front hereof.
- 3. Payment.** Payment can only be made for Products and Services and for quantities ordered on a Rohm Semiconductor India Pvt Ltd Purchase Order. Purchase Order No. must be quoted on the invoice or payment may be delayed. Payment for Products and/or Services will normally be made Thirty (30) days after acceptance and receipt of a correctly rendered invoice, ALL invoices to be forwarded to Finance/Accounts Department, Rohm Semiconductor India Pvt Ltd Unit 4B & 5, Level-02, Bagmane Laurel, Block-B, Bagmane Tech Park, C V Raman Nagar, Byrasandra, Bangalore -560093. Invoices shall conform with the pricing and other details on the Order.
- 4. Taxes.** (i) GST / Customs Duty should be disclosed on all invoices (ii) Prices shall include all duties unless otherwise stated..
- 5. Delivery.** Delivery of Product or performance of Services shall be by the date and to the address specified on the Order. Title shall pass on delivery.
- 6. Acceptance.** All Products delivered and / or Services performed shall be subject to acceptance by Rohm Semiconductor India Pvt Ltd, which shall occur on payment of Suppliers invoice or written notice of acceptance from Rohm Semiconductor India Pvt Ltd, whichever is the earlier. - 7. Warranties.** Products. Supplier warrants that products supplied shall (i) be free of defects in manufacture or workmanship; (ii) be new and of the latest model or style; (iii) conform to its published specifications, including any advertisement and other written media; (iv) be of good merchantable quality; and (v) be fit for the purpose made known to supplier, including compatibility. Services. Supplier warrants that Services shall (i) include all materials and parts necessary to complete such work as part of the prices quoted; (ii) comply with all statutory and regulatory requirements and with applicable International Standards; and (iii) will be performed with due care and skill and shall be fit for the purpose made known to Supplier

Support. Supplier warrants that support and spare parts for the Products and Services will be available in India at reasonable commercial prices and availability for at least a period of Two (2) years from the date of acceptance by Rohm Semiconductor India Pvt Ltd. In the event a defect is discovered and notified to supplier by Rohm Semiconductor India Pvt Ltd within a reasonable period of time after acceptance, Supplier shall promptly at its cost repair or replace the Product with an acceptable replacement, or re-perform the Services, including all incidental work and costs to make good the defective item or work. These warranties are in addition to any implied statutory warranties, which shall apply in full.
- 8. Changes or Cancellation.** Rohm Semiconductor India Pvt Ltd reserves the right to cancel or change the order at any time prior to delivery by notice in writing.
- 9. Patents and Copyright Indemnity.** Supplier shall indemnify Rohm Semiconductor India Pvt Ltd fully against any threats or claims of patent or copyright infringements, including against all costs and losses suffered by Rohm Semiconductor India Pvt Ltd or its customers and damages that may be awarded.
- 10. Confidentiality.** Supplier shall maintain all information disclosed or obtained from Rohm Semiconductor India Pvt Ltd, regardless of form, in strict confidence and shall not use such information for its own benefit.
- 11. Rohm Semiconductor India Pvt Ltd Ownership.** All intellectual property rights in any goods or information provided by Rohm Semiconductor India Pvt Ltd shall remain the exclusive property and right of Rohm Semiconductor India Pvt Ltd. If any designs, tools, plans, drawings or the like are produced by Supplier in the performance of this Order, such shall become the exclusive property of Rohm Semiconductor India Pvt Ltd and shall not be disclosed or provided to any other person and shall be handed over to Rohm Semiconductor India Pvt Ltd on demand. All copyright in the same shall vest exclusively in Rohm Semiconductor India Pvt Ltd.
- 12. Sub-contracting.** Supplier shall not subcontract, transfer or assign any part of this Order without the prior written consent of Rohm Semiconductor India Pvt Ltd.
- 13. Delays.** Supplier shall not be liable for any delays in supply or performance which are beyond its reasonable control provided that it notifies Rohm Semiconductor India Pvt Ltd promptly and takes all reasonable efforts to alleviate such delays. In the event of unreasonable delays or cases of urgency, Rohm Semiconductor India Pvt Ltd reserves the right at its option to cancel the affected Order (s) without liability or penalty.
- 14. Financial Condition.** In the event that Supplier's financial condition is unfavorable, or it becomes insolvent or bankrupt, or enters into a scheme with its creditors, Rohm Semiconductor India Pvt Ltd may at its option and without liability terminate any Order or decline to accept delivery at any time without liability.
