

1.0 Bangalore Electricity Supply Company (BESCOM) is pleased to notify that your offer of ₹ 31,17,03,407/- only (all incl.) (Rupees Thirty One Crore Seventeen Lakhs Three Thousand Four Hundred and Seven only) for Supply, Installation, Configuration and Maintenance of SD-WAN Devices for Data Center, Disaster Recovery Center and Field Offices of All ESCOMs of Karnataka as per the scope of work, terms and conditions stipulated in the tender document published vide ref (1) is accepted.

2.0 The Award of contract for your appointment as Vendor for Supply, Installation, Configuration and Maintenance of SD-WAN Devices for Data Center, Disaster Recovery Center and Field Offices of All ESCOMs of Karnataka is as per the terms & conditions laid down in this office tender Enquiry No.

21.10.2021.

- 3.0 You are requested to enter into a “Contract Agreement” with BESCOM, for a total Contract Price of ₹ 31,17,03,407/- only (all incl.) (Rupees Thirty One Crore Seventeen Lakhs Three Thousand Four Hundred and Seven only) for a period of 5 years from the date of Enterprise Go-Live.
- 4.0 The price breakup of your offer is attached with LOI as Annexure A.
- 5.0 The above contract price is inclusive of GST. BESCOM is not liable to pay any other taxes, whatsoever in respect of this contract. Any increase in the tax should be absorbed by the firm during the contract and any reduction in the tax should be passed on the BESCOM. The prices are FIRM.
- 6.0 You have to comply with the following conditions:
- Your acceptance should reach this office within 7 days from the date of receipt of this letter.
  - POC to be performed for the SD-WAN devices envisaged in the RFP (section II clause 3.8) within 10 days of date of this LOI.
    - To demonstrate SD-WAN functionalities viz. WAN optimization techniques to reduce bandwidth consumption at least by 25%, Mitigating packet drops by at least 10%, sub-second failover.
    - POC shall be conducted in two stages.
      - The full-fledged functionality and the solution shall be demonstrated as a closed room pilot.
      - The solution shall be implemented at two field locations along with one physical and one cloud hub location.
    - The decision on POC implementation success by BESCOM will be considered as final.
  - To furnish the following within 15 days from the date of this LOI:
    - Contract Agreement as per the prescribed format on Karnataka Government e-Stamp paper of value ₹ 200/- shall be furnished.
    - Bank Guarantee issued by a public sector nationalized bank or from Scheduled Commercial Bank towards contract performance guarantee covering 10% of the contract value of each ESCOM. The bank guarantee shall be submitted to each ESCOMs for value mentioned in below table and valid up to 90 days after the end of contract period.


