- Supplier must comply to FSSAI Rules and Regulations and all & any other statutory notification.
- Time is the essence of the Purchase Order, in case delayed/unable in supplying the products as per timelines, Company may procure the products from some other source to meet its requirement in such a case, company shall have the right to recover the differential price amount from supplier.
- Product must meet with the specifications drawn up by Company and Supplier's needs to give a product test report / Certificate of Analysis with delivery of materials and a third party report by accredited agency at supplier's cost during major deviations.
- Company shall be entitled to reject defected Product/material, and Supplier agrees and undertakes to immediately replace such rejected product within 7days at its own cost and expense from the date of intimation, and reimburse the entire cost, damage, expense suffered by Company
- Company shall reject any printed material not meeting the quality & specifications. All rejected Products hereunder are Company's property and shall be destroyed by Company only at supplier's cost.
- Supplier shall be liable for all indirect taxes and the connected requirements and shall obtain, at its cost, such GST registration, permits/passes and other consents as may be necessary for the purpose of dispatch of the Products to Company.
- Challan & Invoice must bear the Purchase Order No. for acceptance of material.
- All disputes shall be resolved by sole arbitrator appointed by Company. Courts at New Delhi shall have exclusive jurisdiction.
- Please quote your and our PAN No. in corresponding Invoice(s)
- The Invoice shall be in a format as prescribed under GST law.
- Delivery Vehicle should enter the plant before 3 PM of business day, failing which the vehicle may get unloaded on the next working day.
- Unloading will happen during 9 AM – 1 PM and 1:30 PM – 5 PM, will solely depend upon the factors like queue, type of material & availability of labor, etc.
