- 1) Supply, installation, testing and commissioning of Servers, Operating System and Switch along with accessories as per technical specifications indicated in Section-III, at Consignee place.
- 2) On-site comprehensive warranty/guarantee for a period of five years from the date of satisfactory installation of equipments.
- 3) Configuration of Servers and Switch connectivity to the existing network.
- 4) Preventive maintenance of equipments once in every year last quarter during warranty/guarantee period and monitor the performance of the equipment and furnish report duly signed by the competent authority/head of the department to the Superintending Engineer (Systems & KERP), Karnataka Power Corporation Limited, 4th floor, KPCL New Building, No.3, Palace Road, Bengaluru-560001 after completion of preventive maintenance each year.
- 5) Corrective maintenance of equipments, as and when required on top most priority and shall furnish corrective maintenance report duly signed by the head of the department or competent Authority to the Superintending Engineer (Systems & KERP), Karnataka Power Corporation Limited, 4th floor, KPCL New Building, No.3, Palace Road Bengaluru-560001.
- 6) Prime shift hours of coverage, i.e, from 9.00 am to 6.00 pm, Monday to Saturday.
- 7) Red Hat Enterprise Linux license shall be provided in the name of KPCL, with 24x7 support.
- 8) Configuration of Servers and Switch and applying updates/patches/firmware as and when released by the OEM.
- 9) Installation/re-install (if required) of operating system (if required) and applying updates/patches as and when released by the OEM.
- 10) Partitioning of storage and configuration as per the requirement.
- 11) If any other accessories required for satisfactory installation and commissioning of Servers, Storage, Operating System and Switch and to bring them to network shall be provided without any extra cost.
- 12) Shifting of existing ODA X7-2HA server from Shakti bhavan, Bengaluru to DR site at Bellary Thermal Power Station, Kudithini, Ballari Dist. with complete packing (using Antistatic bubble sheet, poly urethane foam sheet, standard carton box) loading, transportation, unloading and transit insurance after satisfactory installation of the new servers.
- 13) Collection of logs and submission of the logs for further analysis of OEM for implementing the solution to resolve the incidents, if any.

**2 Prices:** The price shall remain FIRM throughout the contract period on F.O.R destination basis. Any variation in rates of taxes and duties, levies will be reimbursed on production of documentary evidence during the contract period only.

**3 Terms of Payment :** Payments will be made as below:

- a) 90% payment of contract value inclusive of all taxes will be made after satisfactory supply, installation, testing and commissioning of Servers along with its accessories and submission of invoice for 100% of total contract value.
- b) 10% payment of total contract value inclusive of all taxes will be released in five equal installments after submission of yearly preventive maintenance and corresponding Corrective maintenance reports (if any).

**4 Contract Period:** Contract period shall mean 45 days completion period plus 5 years warranty/guarantee period from the date of satisfactory installation of 2 nos. Servers and Accessories and shall include any extension of time thereof.
