**Payment Terms:** Monthly on receipt of Invoice with stakeholders confirmation, Taxes extra as applicable, Billing on Ship to location as per GST Norms..... **Standard Terms Conditions** 1.Acceptance of terms conditions: The Purchase Order (PO) is being released in favour of above named vendor (hereinafter referred to as Vendor). The order is subject to the terms mentioned in the PO and any other documents required to be executed by Bajaj Allianz Life Insurance Company Limited (hereinafter referred to as Bajaj Allianz). The acceptance of PO by the Vendor shall be deemed to mean that the Vendor agrees to and confirms that it shall abide by the terms mentioned in the PO read along with any other document executed in furtherance to the same. The Vendors full or partial performance under this PO will be deemed to be and constitute as Acceptance of these terms and conditions. Non acknowledgement of the terms and conditions of the PO and in the event of partial or full performance of the services shall be construed as acceptance of the terms and conditions of the PO.2.Guarantee/Warranty Period: The Products/Services being offered/provided in accordance to the PO shall come with the Standard Manufacturing Warranty and/or stipulated Warranty and

Guarantee conditions as may be specified. The relevant Certificate should be submitted for the agreed period from the specified date for the delivery of goods/services, and for any deficiency in supply of goods/rendering of services during the warranty period. Vendor shall provide the material/goods/services as per the PO and arrange for the replacement of damaged goods/shortage of goods/ and/or alternative /appropriate services as reported by Bajaj Allianz, within the specified timelines as communicated by Bajaj Allianz to the Vendor. 3.Insurance: The Vendor shall at his own cost maintain sufficient insurance cover for their men/materials/tools etc. as may be communicated in the PO. The Vendor shall ensure to cover their workmen under the Workmens Compensation Insurance. The Vendor shall submit the required documents in proof as and when called upon by Bajaj Allianz. 4.Timelines: The Vendor shall provide the Goods/Services within the specified timelines prescribed in the PO. 5.Inspection: All Goods to be supplied and/or Services to be provided are liable to inspection prior to final acceptance by Bajaj Allianz. The material or goods are required to be same as per the final sample approved by Bajaj Allianz and/or as communicated in the PO.6.Governing Law: This PO is governed by and construed in all respects in accordance with the laws of India Parties shall submit all and any conflicts to the courts of Pune jurisdiction. 7.Taxes Duties: Unless otherwise mentioned in the PO, the prices mentioned in the PO are inclusive of all taxes and duties including entry level tax/Octroi, etc. GST, if applicable, shall be borne by the Vendor. The Vendor shall be entitled to claim reimbursement of the GST by raising appropriate and timely invoices by submitting the requisite details, whereby Bajaj Allianz is able to claim appropriate tax credits. All payments shall be made after deduction of statutory amounts/taxes, required under the law. The applicable TDS will be deducted on the gross bill value as per the prescribed rate of the Act. 8.Payment terms: The payment of the rates shall be made only after the delivery of Goods/Services to the satisfaction of Bajaj Allianz, unless otherwise agreed by Bajaj Allianz in writing. Payments shall be subject to receipt of appropriate and correct invoices along with supporting documents and information.9.Penalty: Bajaj Allianz reserves the right to claim Penalty and Liquidated Damages for unsatisfactory services and goods being provided. 10.Indemnification: The Vendor shall defend, hold harmless and indemnify including legal fees Bajaj Allianz against any and all damages/ loss/claims/demands/litigations of whatever nature and kind including for any acts or omissions and breach of the terms of PO. Bajaj Allianz's entire liability to Vendor shall be restricted to timely payment of applicable fees/service charges to Vendor as agreed in the PO.11.Confidentiality: The Vendor shall maintain all the confidential information received from Bajaj Allianz as confidential during the term of the PO and thereafter. Bajaj Allianz shall not be held liable if the Vendor fails to inform Bajaj Allianz of the MSME status.17.Vendor is the lawful owner of the Goods and/or services provided under this PO. Bajaj Allianz shall be entitled to rely on the title and ownership of the Vendor. 18.Bajaj Allianz shall be entitled to conduct audits and quality checks of the work assigned under this PO on prior written confirmation.19.The Vendor shall adhere and comply with The National Guidelines on Responsible Business.
