b) **Payment Terms** – The payment will be released as follows:

- 90% of the total cost and 100% of GST after one month of delivery of Network Cable. (POD document signed by the concerned Bank officials to be provided along with invoice for release of payment).
- Balance amount of 10% will be released against Bank Guarantee by a scheduled commercial bank other than Bank of Baroda valid for an equivalent amount valid for the period of One Year.

The payment will be released from IT Dept., BCC as per the payment terms on submission of related documents.

But, any benefit arising out of any subsequent reduction in the prices due to reduction in duty & taxes after the prices are fixed and before the delivery should be passed on to the Bank.

- c) **Dead on Arrival (DOA)** - Connectivity IT Solutions Pvt Ltd. has to ensure that any equipment supplied as part of this order should not be dead on Arrival (DOA). In the event if any Network Cable supplied by Connectivity IT Solutions Pvt Ltd. Ltd. is dead on Arrival (DOA), Connectivity IT Solutions Pvt Ltd. has to replace the equipment at no additional cost to the Bank.
