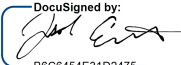

The prices stated on this PO hereof are firm and shall remain firm until deliveries have been completed unless otherwise expressly agreed to in writing by both the parties. The Vendor agrees that any price reduction made with respect to goods/ services covered by this PO subsequent to placement will be applied to this PO. Unless otherwise specified in writing by Zinnia, no price variation on any account will be allowed. Unless otherwise specified, the prices include all kind of taxes, duties, transit insurance, insurance coverage for storage, testing and commissioning if any, etc

All goods and services furnished hereunder will be subject to inspection and test by Zinnia at all times and places and will be subject to Zinnia's final inspection and approval within a reasonable time after delivery. Zinnia may reject goods and services not in accordance with Zinnia's instructions, specifications, drawings, data, or the Vendor's warranty (expressed or implied), or for untimely delivery. Zinnia may return rejected goods to the Vendor at the Vendor's expense and Zinnia shall have no further obligation for such goods. Payment for any goods or services shall not be deemed acceptance and in no event shall Zinnia incur any liability for payment for rejected goods or services. No inspection (including source inspection) test, approval (including design approval) or acceptance of goods shall relieve the Vendor from responsibility for defects or other failures to meet the requirements of this PO. Rights granted to the Vendor in this article entitled inspection are in addition to any other rights or remedies provided elsewhere in this PO or in law.
