
The Supply, Installation & Commissioning of above DCIT components are subjected to the following terms and conditions:-

1. The supply & Installation should be made within 08 weeks from the date of receiving the work order as the DCIT components are urgently installed to KSP Data Center on high priority.
2. The above mentioned price is inclusive of all taxes.
3. The DCIT Components shall be supplied as per the tender specifications mentioned in the Tender Document of KSP Data Center.
4. The substandard goods/materials will be replaced at your cost as per specification.
5. A work completion report from Officer Incharge of KSP Data Center to be submitted after successful installation and commissioning of deliverables.
6. Warranty period shall be three years from the date of satisfactory installation of DCIT components.
7. 60% payment of the contract price shall be processed against the successful delivery of DCIT components in full and good condition on submission of certified documents as per tender clause 10.2
8. 40% of the contract price shall be processed against successful installation & commissioning of DCIT components on submission of certified documents as per the SLA agreement.
9. A Performance Bank Guarantee should be executed in the name of Additional Director General of Police, Police Computer Wing, Bengaluru for 3% of the contract value with the validity of 36 months.
10. A Service Level Agreement shall be signed within 7 days after accepting the supply order as per the terms and conditions and scope of work laid down in the tender document on Rs.500 e-Stamp paper. The SLA format is already provided in the RFP.
11. If it is found that the articles are substandard, the same will be rejected and shall be replaced at free of cost same as SL No.04.
12. All repairs replacements should be carried out at free of cost within the warranty period.
13. All terms and conditions mentioned in the tender should be strictly adhered, failing which legal action for non performance as per SLA will be initiated.
14. Pre-Dispatch Inspection will be held before supply & Installation of DCIT components as per the tender conditions.
15. Pre-Dispatch Inspection shall be conducted within 10 days from the date of intimation of deliverables readiness.
