Dear Sir,

The following two machine at Power Line shop, H&P Division, KGF is disconnected from industry 4.0 network due to cable fault:

1. SBCNC Machine 555050_030 - Network from Switch to Machine is down.
2. SBCNC Machine 555050_040 - Network from Switch to Machine is down.

The Cat6 cable was found entangled in the overhead crane path and cut in multiple places between Switch placed at Power line Shop to the above said two machines.

The cable was also inspected by Engineers from M/s. Connectivity Solutions during their visit November 2023 and the network survey during December 2023. As this is a critical requirement and the Shielded cable is not available locally, You are requested to help us resolve the same at the earliest.

The job involves laying of approx (60*2) 120 meters of Shielded Cat-6 Cable on overhead PVC pipes and also involves cutting the concrete on the shop floor for routing the cable to the two machines.
