Each ASR router shall include ASR1000-SIP10, three SPA-1X10GE-L-V2 and Appropriate and sufficient SFP modules and Power Cable and the cost includes installation with Rack Mounting and initial configuration at the designated LIC site. The rental charges shall accrue w.e.f. the date of installation of the respective routers.

1. You are required to install at least 03 nos. (three) of 10G interfaces (Two for WAN and One for LAN) installed with appropriate SFP modules along with all accessories such as adapters, cables, power cables, plugs compatible with Indian Electrical connections, etc.
2. The Routers should support DMVPN, GETVPN and all the IOS supported features of ASR Routers.
3. No separate freight charges will be paid for delivery of the routers at the designated LIC locations.
4. In case, if the routers does not provide the above features or do not meet our requirements, the routers will be returned to you without any rental payments.
