Service Level Agreement: (Annexure 1)

1. Support Window: 24x7 4. If RMA is not possible, Connectivity will provide standby device till RMA reach at site. Define the Sunday/Holidays Support Model.
2. Response time: 15 Minute from logging the call at Connectivity call center response will be of Email/telephonic/Onsite.
3. In case of Hardware failure, call will be logged with Connectivity Helpdesk for replacement of faulty Hardware. In case of hardware failure Connectivity will be providing functionally equivalent spare/standby on the earliest arrangement, NBD or on best effort basis for locations where road permit or some documentation is required from IndusInd side for shipment of goods.
4. The onsite support will cover:
 - a. Intelligent Hand support (IHS) for Hardware replacement.
 - b. Replacement of defective device with functionally equivalent spare/standby.
5. DC, DR, NDR and Critical HUB location devices would be responded within 1 hour.
6. Pre and post installation OS update will be done by Connectivity engineer.
7. Post installation for any hardware or software issues, Connectivity FE (field engineers) will be aligned to rectify the issue.
8. Patches, Bug-Fix, advisory and Vulnerability support will be provided by Connectivity in coordination with CISCO as and when presented. Reports will be shared duly with Bank.
9. All metro Cities across the country within 2 hour. Urban 3 hour, Semi urban 4 hour and rural 5 hour.
 - a. Remarks/Suggestion- As a partner we would appreciate if and when required in case of any emergency for third party hardware failure, Connectivity will support us in replacement of devices wherever possible on best effort basis.
