Other Terms and Conditions:

1. Payment Terms:

- The overall contract value shall be INR 1,65,49,369 inclusive of GST;
- The entire payment towards Supply shall be on credit of 90 days, against PDC, from the date of raising an Invoice and supply of the entire lot of IT equipments indicated above. All material supply shall be completed on or before 1st week of April 2021. The payment will be honoured only after installation and commissioning and acceptance by the end client. In the event there are issues in installation and commissioning 20% of the payment will be with held. WLC, Access Point, Core Switch and MPLS Router to be kept on supply hold till end client confirmation.

2. Following documents to be provided :

Invoice in Duplicate, Warranty letter from OEM in the name of End Client, Factory Acceptance Test, Compliance, Operating and User Manual and Completion certificate from End User duly signed and stamped.

3. The comprehensive On-Site Warranty of the equipment supplied shall be for 5 years from the date of Go-Live. Necessary back-to-back arrangements to be made with the OEMs. All warranty certificate shall be obtained from End OEM in the name of End Client.

4. Any issue pertaining to the material supplied shall be resolved at the project site only. BOM as per the Annexure. Any shortfall or component missing from BOM to meet the technical/functional requirement as mentioned in the tender and subsequent addendums need to be delivered by the supplier. Any liability incurred by DIWL owing to down time on account of OEM/Partner default resulting in non adherence of SLA will have to be borne by Connectivity.

6. Temporary storage shall be in the scope of Supplier, if there is no space provided by end client after the receipt of all the material.

5. Installation time frame shall be 2 week after receipt of all the material, subject to availability of site. Stoppage of work for reasons beyond the control of any of the stake holders & due to non-payment of Invoices affecting continuation of seamless work shall add on to the above agreed timelines.

6. Any dispute arising out of this work, shall be amicably solved. If the same is not solved amicably the same will be resolved in the High Court of Bengaluru.

7. The supplier shall provide Country of Origin and adherence to DPIT guidelines. In case of Make In India, supplier class to be provided
