In the event of such cancellation, the Purchaser may get the order executed by any other party and claim from the Supplier any loss the Purchaser may suffer thereby including difference between the cost incurred by the Purchaser and the order price.

17. Should the Supplier fail to deliver materials/works within delivery time specified, the Supplier shall be liable to pay to the Purchaser liquidated damages for delayed delivery at the rate of 2% of the price of the materials/works not delivered in time for every week or part thereof during which the stipulated delivery time is exceeded. The payment of liquidated damages shall not, however, absolve the Supplier from the delivery obligations.

18. The Purchaser may on written notice to the Supplier terminate the order if the Supplier:

- i. has materially breached any of its material obligations under this terms and conditions of the Order and such breach is not remedied within fifteen days of receiving the written notice;
- ii. any bankruptcy event occurs;
- iii. ceases to carry on its business.


The provisions of the terms and conditions of the Order which survive by its nature shall survive the expiry, cancellation or termination of the order.

19. Neither party shall be liable to the other for any delay in delivery or accepting scheduled delivery, if caused by circumstances constituting force majeure such as fire, strike, lockout, riot, war, Government orders, regulations and legislation, acts of God and/or any other contingency beyond reasonable control of the respective parties. The Purchaser shall have the option to cancel the order wholly or partly in the event of force majeure extending beyond the fifteen days.
