The Service Provider or its employees shall not enter restricted areas and not touch or operate any material, equipment, pipeline, valves, switches, etc., unless specific permission is received from the concerned department.
4. The employees/ labours/ sub-contractors of the Service Provider working in the premises shall wear necessary safety PPEs and use appropriate equipment correctly during the execution of the work.
5. Penalty would be levied onto the Service Provider for any safety violations observed during the contract period. The amount of such penalty shall be ascertained at the discretion of the Company based on the nature of violation.
6. The relationship with the Service Provider shall be of independent contractors only.
