4. The supplier agrees not to make any use of tooling, data, designs, drawings, specifications, art work and other information furnished to it by the APPL or create under, except for performance of the order.
5. APPL and supplier, and it is agreed by the supplier that none of the details connected here with shall be published or disclosed any third party without APPL permission.
6. The supplier shall comply with all applicable Indian laws, statutory requirements, directives and regulations concerning the provision, manufacturing, marking, labelling, packaging and delivery of the goods and to performance of the services including but not limited to the Environment Safety, health and welfare at work place act.
7. The contract shall be governed by and customer in accordance with the laws of India, and the parties shall submit to the exclusive jurisdiction of the courts in Bangalore.
8. Suppliers whoever delivering the items/materials through their own vehicles/outsourced vehicles shall have regulatory approved wheel-choke within the vehicles and it shall be used while parking the vehicle inside the factory premises.
